

Terms and Conditions
Sustainable Economy in Horizon Europe –
International Matchmaking & Networking (Edition 2024)
23-24 October 2024

1. These Terms and Conditions set out the conditions, procedure and rules under which the event - Sustainable Economy in Horizon Europe - International Matchmaking & Networking (Edition 2024) in Warsaw – hereinafter referred to as the “Event” - is held on 23-24 October 2024.
2. The Organizers of the Event are:

Hereinafter also individually referred to as “Organizer” or collectively as “Organizers”.

3. The Event is related to the undertaking launched and funded by the Minister of Education and Science "Industry Contact Points for the Horizon Europe Framework Program for Research and Innovation" (Announcement of the Minister of Education and Science dated January 4, 2022 on the establishment of the undertaking "Industry Contact Points for the Horizon Europe Framework Program for Research and Innovation" on January 10, 2022, issued pursuant to Article 376(1) of the Law of July 20, 2018. - Law on Higher Education and Science; i.e., Journal of Laws of 2022, item 574).
4. The number of participants at the venue of Event is limited.
5. Application for participation is free of charge and is made through the Application Form available on the Event site created via the platform <https://www.b2match.com/>. The regulations for using the platform and the rules for processing and securing user data are set out in the documentation, which can be found on the website <https://www.b2match.com/>:

6. Provision of personal data is voluntary but necessary for the proper completion of the application.
7. In order to complete the application, it is required that the User reads and accepts the contents of the Terms and Conditions of the Event and the rules for personal data processing.
8. The Participant may cancel participation earlier by notifying the Organizer in writing or by sending an email to the Organizer’s addresses.
9. Participants in the Event, in order to facilitate participation in the Event, will be offered a hotel base. However, the Participant will be required to personally book and pay the cost of accommodation and other hotel services. The Event Organizer is not responsible for the Participant’s individual arrangements with the hotel service provider.
10. On the day of the Event, a registered participant who has arrived at the venue of the Event shall be required to confirm the participation on the list. The list will be part of the documentation confirming the execution of the Event and will be kept with other documents, including accounting documents, for the period required by the law, not exceeding 10 years.

11. The Organizer is not liable for damages resulting from entering incorrect data into the form by persons registering their participation in the Event.
12. During participation in the Event, a registered participant shall:
 - a) follow the instructions of the Organizers' representatives,
 - b) comply with the instructions of the services, if any, at the place of the Event,
 - c) comply with the current rules and restrictions related to epidemiological risks and fire regulations in force at the place of the Event,
 - d) behave in a manner that is consistent with the rules of social relations and does not prevent other persons from participating in the Event.
13. The Event will be recorded and photographic documentation will be prepared.
14. The Organizers act as separate administrators of personal data performing their tasks in the organization of the Event. Appendix No. 1 to these Regulations constitutes a clause implementing the information obligation under Article 13(1) and (2) of the Regulation of the European Parliament and of the Council (EU) 2016/679 of April 27, 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data and repealing Directive 95/46/EC (General Data Protection Regulation) - hereinafter referred to as "GDPR". 15. During the Event, there can be an online transmission of the speakers' presentations, which will be recorded for archival purposes, while the Organizer may conduct photo sessions, from which photographs as well as short films will later be used for broadcasting in mass media (primarily the Organizer's website and social media) or for documentation, promotion, advertising of the Event and the Organizer. Presence in the venue of the Event is tantamount to the Participant's consent to the recording, use and/or distribution by the Organizer and its affiliates of the image/voice/speech of each Participant in all promotional and marketing materials without time and territorial restrictions.
16. The participant hereby waives all claims (existing and future), including for remuneration against the Organizer for the use of his/her image/voice/speech for the purposes specified in these Regulations.
17. The Organizer reserves the right to change the speakers and/or the program of the Event at any time, without giving reasons, as well as to cancel or reschedule the Event due to extraordinary circumstances.
18. Participants shall bear full financial responsibility for the damage they cause to the premises where any activities related to the Event are conducted.
19. The Organizer is not responsible for items lost or left by the participant during the Event.
