Purposes and legal basis for processing

Your personal data in the registration form are provided for the purpose of the Event organization and communication with participants on matters related to the organization of the Event, conducting online broadcasts of speakers' presentations, making documentation of the proceedings, including compiling a list of participants and for archival purposes. The legal basis for processing of the data is primarily the execution of a task carried out in the public interest¹ in order to implement the state's scientific policy.

The course of the event will be recorded on video and in a photo report in order to promote the event and disseminate information provided during the event. Personal data in the form of captured images will be processed to document and promote the Event. A recording will be made of the Event for archival purposes. The legal basis for processing the data is the legitimate interest of the Administrator².

Personal data included in the list of participants will be part of the documentation confirming the implementation of the event after its closing and will therefore be processed on the basis of the law³ in terms of the obligation to document the organization of the Event and eligibility of the spending of the funding.

Recordings and photographs taken during the Event are intended to perform a task carried out in the public interest⁴ in order to implement the state's science policy. However, if you have given additional consent to the processing of your personal image data for the purpose of the Event promotion then the consent is the legal basis for the processing of the data⁵.

If you have expressed a desire to receive the Newsletter the consent is also the legal basis for processing the data⁶.

Data storage period

Your personal data will be processed for the duration of the Event, and after its completion for the period necessary to keep the documentation confirming the proper financing of the Event, not more than 6 years, and in the case of data processing in the form of image - for the period necessary to promote the Event after its completion in order to make organization of the next edition of the Event possible, and to archive confirmation of its completion – until you withdraw your consent.

Recipients of data

Access to your personal data will be provided to authorized employees, collaborators of the other organizers of the Event. Recipients of your data may be entities that provide IT services to the Co-Administrators, but always on the basis of a data processing entrustment agreement and only in accordance with the Administrator's instructions. Recipients may also be the Center of the Łukasiewicz Research Network within the framework of its supervisory functions and authorities authorized by law.

Obligation to provide data and the consequence of not providing data

The provision of personal data is voluntary, but necessary to make your participation in the Event possible. With regard to your personal data, decisions will not be made by automated.

Rights related to data processing

You have the following rights related to the processing of your personal data: the right to access your personal data, the right to request the rectification of your personal data, when there is no longer a basis for its processing - the right to request the erasure of your personal data, and if there is a basis for it - to request the restriction of its processing. To the extent that your data is processed on the basis of the legitimate interests of the Administrator, you also have the right to object to the processing of your data due to your particular situation. To the extent that your data is processed for marketing purposes on the basis of our legitimate interest, you have the right to file an unconditional objection to the processing of your data for this purpose.

If we process your data on the basis of consent, you have the right to withdraw your consent at any time. Withdrawal of consent does not affect the legality of the processing that was carried out on the basis of the consent before its withdrawal

Right of complaint

You also have the right to lodge a complaint with the supervisory authority in charge of personal data protection, i.e. the President of the Office for Personal Data Protection.
