- BY THE END OF THE WINTER SEASON IN EARLY 2022, UNHOUSED FOLKS SPENT A TOTAL OF 1,731 NIGHTS IN SEASONAL SHELTER WITH OVER 50% OF PROGRAM PARTICIPANTS EXITING INTO PERMANENT HOUSING.

- DURING THE 2022-2023 SEASON, 406 PEOPLE WERE REFERRED BY NEOCH WITH A TOTAL OF 6,759 NIGHTS SPENT IN SEASONAL SHELTER.

- RESPONDED WITHIN 48 HOURS TO ALL 488 CALLS FROM THE COMMUNITY CONCERNING PEOPLE EXPERIENCING HOMELESSNESS IN THROUGHOUT THE YEAR. O HOSTED 22 CLEVELAND OUTREACH COLLABORATIVE MEETINGS TO COORDINATE AND IMPROVE SERVICES FOR THOSE LIVING ON THE STREETS.
