

NVIDIA LAUNCHPAD TERMS OF USE

These terms are a legal agreement between you and NVIDIA Corporation ("NVIDIA") for the use of the NVIDIA Launchpad, as updated from time to time.

By using the NVIDIA LaunchPad, you are affirming that you have read and agree to these terms.

These terms can be accepted only by an adult of legal age of majority in the country in which the NVIDIA LaunchPad is used.

If you are not old enough to enter into these terms or if you don't accept all the terms and conditions below, do not use the NVIDIA LaunchPad.

You agree to use the NVIDIA LaunchPad only for purposes that are permitted by (a) these terms, and (b) any applicable law, regulation or generally accepted practices or guidelines in the relevant jurisdictions.

1. Offering

The NVIDIA LaunchPad consists of services, software and content that enable you during your trial period to try certain NVIDIA products or services (the "Trial Offerings"), together with User Content (as defined below) uploaded by you or other users to LaunchPad, from NVIDIA servers. NVIDIA will at its sole discretion define which Trial Offerings will be available for you to try. Trial Offerings are subject to their applicable terms and conditions. While under the applicable terms and conditions for Trial Offerings you may generally have broader uses, as part of the NVIDIA LaunchPad trial your ability to use a Trial Offering may be more limited. To the extent that there is a conflict between these terms and the terms of use for specific Trial Offerings, these terms govern with respect to NVIDIA LaunchPad trials.

Under these terms NVIDIA grants you a personal, non-exclusive, non-transferable license to access and use the NVIDIA LaunchPad platform for you to try the Trial Offerings without use in production.

NVIDIA LaunchPad is available only for test purposes and may have design flaws, and reduced or different security, privacy, availability, and reliability standards relative to commercially provided NVIDIA software, materials and services. You will be provisioned for trial purposes with a NVIDIA hosted platform where you will be responsible for the secure deployment and management of the platform, as well as the security of applications and services you deploy on the platform. While NVIDIA LaunchPad is deployed in accordance with industry recommended practices, NVIDIA does not provide assurance over the security of your provisioned platform once handed over to you.

2. User Content

In connection with NVIDIA Launchpad, you may be able to upload content that you separately own or have rights to use ("User Content") to NVIDIA servers. When private repositories are available, you can access, use, modify, organize and share User Content in such repositories privately with other users that have access to the same repositories as you.

You represent that you either own the User Content or you have all rights, licenses, consents and releases that are necessary to grant the rights for others to use the User Content you provide as contemplated under these terms. You are solely responsible for compliance with all applicable laws, statutes, regulations, rules, orders and guidelines, whether local, state, provincial, national, or international, with respect to User Content you upload to NVIDIA servers.

NVIDIA does not guarantee that all User Content can be used in or with NVIDIA Launchpad or a Trial Offering. NVIDIA does not support, endorse or assume any responsibility for any User Content or its accuracy or usefulness.

You hereby grant NVIDIA, its affiliates, their personnel and NVIDIA suppliers and service providers a non-exclusive, worldwide, limited license to access, use, copy, display and transmit User Content in connection with the provision of NVIDIA Launchpad, to provide you support, or for security reasons. YOU ACCEPT SOLE RESPONSIBILITY FOR AND ASSUME ALL RISK ARISING FROM USER CONTENT IN YOUR ACCOUNT(S). Any User Content in NVIDIA servers is shared at your sole risk and you understand it

can be read, collected, used and modified by those with access to the same repositories and NVIDIA is not responsible for their use of such User Content. You acknowledge that NVIDIA does not manage or control User Content that you upload, access, store, or distribute through NVIDIA servers, and accepts no responsibility or liability for that information regardless of whether such User Content is transmitted to or by you in breach of these terms. You acknowledge and agree that NVIDIA may, but is not obligated to, block, monitor, scan or review communications or content transmitted through the NVIDIA LaunchPad and that NVIDIA shall not be responsible for the content of any such communications or transmissions but may remove content as it deems appropriate, including if content: doesn't comply with these terms; pose a security risk; doesn't comply with the rights of others; or doesn't comply with applicable law, rule or regulation, or the order or requirement of a court, administrative agency or other governmental body.

In connection with providing or otherwise making available User Content through NVIDIA servers, you represent and warrant that neither the User Content nor your posting, publication, submission or transmittal of it or the use of it (or any portion thereof) will: (a) infringe, misappropriate or violate a third party's patent, copyright, trademark, trade secret, moral rights or other intellectual property rights, or rights of publicity or privacy, or otherwise violates the terms under which you are licensed; (b) contain mass mailings or any form of "spam"; (c) express or imply any endorsement of your User Content by NVIDIA; or (d) violate applicable national or international laws, rules and regulations, including (but not limited to) export and import laws and regulations.

You further represent and warrant that neither your actions nor your posting, submission or otherwise transmission of User Content or other material will: (i) violate, or encourage any conduct that would violate any applicable law or regulation or would give rise to legal liability; (ii) be fraudulent, false, misleading or deceptive; (iii) be defamatory, obscene, pornographic, vulgar or offensive; (iv) promote discrimination, bigotry, racism, hatred, harassment or harm against any individual or group; (v) be violent or threatening or promote violence or actions that are threatening to any other person; (vi) promote illegal activities; (vii) contain any malware, viruses, drop dead device, worm, trojan horse, trap, back door or other software routine that is designed to delete, disable, deactivate, interfere with or otherwise harm any software, program, data, device, system or service, or which is intended to provide unauthorized access or to produce unauthorized modifications; (viii) use any robot, spider, data scrapping or extraction tool or other similar mechanism with respect to NVIDIA servers; or (ix) interfere with or disrupt the security, integrity or performance of NVIDIA servers, NVIDIA Launchpad or Trial Offerings, attempt to probe, scan or test the vulnerability of NVIDIA servers, NVIDIA Launchpad or Trial Offerings, or collect or store any personally identifiable information from other users. You are responsible for the consequences of User Content that does not conform to these limitations.

3. Your Privacy

NVIDIA may require certain personal information such as name and email address in order to deliver or provide the services to you.

4. Restrictions

Your use of the NVIDIA LaunchPad, including NVIDIA-provided software and materials, is subject to these restrictions:

4.1 You may not use the NVIDIA LaunchPad, including its internet connection, for any purpose other than as described in section 1 above.

4.2 You may not copy, sell, rent, sublicense, transfer or distribute or make available to others any portion of the NVIDIA LaunchPad.

4.3 You may not use NVIDIA servers for general cloud storage of your data. Further, you are solely responsible for any content that you upload or store, including any personal information relating to an identifiable individual, financial, health or

governmental information, or any other information which may be subject to data privacy or data security laws, rules, or regulations.

4.4 You may not reverse engineer, decompile, disassemble, modify, create derivative works or remove copyright or other proprietary notices from any portion of the NVIDIA LaunchPad.

4.5 You may not misuse, disrupt or exploit the NVIDIA LaunchPad or NVIDIA servers for any unauthorized use, or try to access areas not intended for users, or use NVIDIA servers for any form of excessive automated bulk activity, or to relay any other form of unsolicited advertising or solicitation.

4.6 You may not use NVIDIA LaunchPad to create or distribute to others any defamatory, obscene, pornographic, vulgar, offensive or violent content.

4.7 You shall not use NVIDIA LaunchPad with any system or application where the use or failure of such system or application can reasonably be expected to threaten or result in personal injury, death, or catastrophic loss including, without limitation, use in connection with any avionics, navigation, military, medical, or life support or other life critical application ("Critical Applications"). You acknowledge that NVIDIA does not design, test, manufacture or certify NVIDIA LaunchPad for use in the context of a Critical Application or processing of controlled or sensitive data, including (but not limited to) protected health information, personal data, payment card industry information or sensitive human subject research data such as biometric data, and NVIDIA shall not be liable to you or any third party, in whole or in part, for any claims or damages arising from such use.

5. The NVIDIA LaunchPad General Terms

5.1 Ownership. The NVIDIA LaunchPad, including related intellectual property rights, is and will remain the sole and exclusive property of NVIDIA or its licensors. Except as expressly granted, NVIDIA and its licensors reserve all rights.

5.2 Feedback. NVIDIA and its affiliates are free to use any comments, information, ideas, concepts, reviews, or techniques or any other material contained in any communication you may send to NVIDIA or its affiliates regarding the NVIDIA LaunchPad ("Feedback"), including responses to questionnaires or through postings to the NVIDIA LaunchPad, including the NVIDIA website and user interfaces, without further compensation, acknowledgement or payment to you for any purpose whatsoever, including, but not limited to, developing, manufacturing and marketing products or services and creating, modifying or improving the NVIDIA LaunchPad, and you hereby assign to NVIDIA any and all rights, including but not limited to intellectual property rights, in any Feedback you provide. In addition, you agree not to enforce any Moral Rights (as defined below) in and to the Feedback, to the extent permitted by applicable law. A "Moral Right" means any right to claim authorship of a work, to object to or prevent the modification or destruction of a work, to withdraw from circulation or control the publication or distribution of a work, any similar right, existing under judicial or statutory law of any country in the world, or under any treaty, regardless of whether or not such right is called or generally referred to as a "moral right." If you send any Feedback, whether or not solicited, you do so with the understanding that no additional consideration of any sort will be provided to you, and you hereby irrevocably waive any claim against NVIDIA and its affiliates regarding the use of such Feedback, even if information, an idea, concept, technique or material is used that is substantially similar to the Feedback you sent.

5.3 Updates. NVIDIA may at any time change, discontinue, or deprecate any part, or all, of the NVIDIA LaunchPad, or change or remove features or functionality of the NVIDIA LaunchPad, and your continued use of the NVIDIA LaunchPad is deemed acceptance of such changes. Additionally, the NVIDIA LaunchPad may be temporarily unavailable, inaccessible or slow when NVIDIA is performing maintenance or upgrades or at other times for reasons not within NVIDIA's reasonable control.

5.4 Components Governed by Other Licenses. The NVIDIA LaunchPad may come bundled with, or otherwise include or be distributed with, components with separate legal notices or terms as may be described in proprietary notices accompanying the NVIDIA LaunchPad software or as described in documentation.

In addition to any liability you may have to NVIDIA, you agree that you will also be legally responsible directly to LaunchPad

suppliers for any breach of these terms in relation to your use of the supplier products made available for your use via LaunchPad. The suppliers of LaunchPad products are intended third party beneficiaries of these terms. By using Launchpad, you agree to provide to NVIDIA, and that NVIDIA may disclose to a LaunchPad supplier, information requested with respect to use of applicable products and to verify your compliance with these terms.

5.5 Indemnity. By using the NVIDIA LaunchPad you agree to defend, indemnify and hold harmless NVIDIA and its affiliates and their respective officers, directors, employees and agents from and against any claims, disputes, demands, liabilities, damages, losses, costs and expenses arising out of or in any way connected with: (a) your use of the NVIDIA LaunchPad in breach of these terms, or (b) User Content (including, but not limited to, claims that they violate applicable laws, or infringe, violate, or misappropriate any third party right or slander, defame, or libel any other person).

6. Termination

6.1 If you want to terminate these terms, you may do so by stopping your use of the NVIDIA LaunchPad.

6.2 Your right to use the NVIDIA LaunchPad terminates automatically without notice from NVIDIA (a) if you fail to comply with these terms, (b) if you engage in illegal or improper use of the NVIDIA LaunchPad, or (c) if you commence or participate in any legal proceeding against NVIDIA with respect to the NVIDIA LaunchPad. Additionally, NVIDIA may at any time terminate the availability or your use of the NVIDIA LaunchPad.

6.3 After termination of these terms or an applicable trial NVIDIA has no obligation to retain and may delete or otherwise cease to provide access to the Trial Offerings and any other content (including User Content) associated with the trial at any time. All provisions of these terms which by their nature should survive termination will survive termination, including, without limitation, ownership provisions, warranty disclaimers, indemnity, and limitations of liability.

7. No Warranties

THE NVIDIA LAUNCHPAD AND ANY USER CONTENT THAT YOU MAY ACCESS IS PROVIDED BY NVIDIA "AS IS," "AS AVAILABLE" AND "WITH ALL FAULTS." TO THE MAXIMUM EXTENT PERMITTED BY LAW, NVIDIA AND ITS AFFILIATES EXPRESSLY DISCLAIM ALL WARRANTIES OF ANY KIND OR NATURE, WHETHER EXPRESS, IMPLIED OR STATUTORY, INCLUDING, BUT NOT LIMITED TO, ANY WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, TITLE, NON-INFRINGEMENT, OR THE ABSENCE OF ANY DEFECTS THEREIN, WHETHER LATENT OR PATENT. NO WARRANTY IS MADE ON THE BASIS OF TRADE USAGE, COURSE OF DEALING OR COURSE OF TRADE.

8. Limitation of Liability

TO THE MAXIMUM EXTENT PERMITTED BY LAW, NVIDIA AND ITS AFFILIATES SHALL NOT BE LIABLE FOR ANY SPECIAL, INCIDENTAL, PUNITIVE OR CONSEQUENTIAL DAMAGES, OR ANY LOST PROFITS, LOSS OF USE, LOSS OF DATA OR LOSS OF GOODWILL, OR THE COSTS OF PROCURING SUBSTITUTE PRODUCTS, ARISING OUT OF OR IN CONNECTION WITH THESE TERMS OR THE USE OR PERFORMANCE OF THE NVIDIA LAUNCHPAD AND USER CONTENT, WHETHER SUCH LIABILITY ARISES FROM ANY CLAIM BASED UPON BREACH OF CONTRACT, BREACH OF WARRANTY, TORT (INCLUDING NEGLIGENCE), PRODUCT LIABILITY OR ANY OTHER CAUSE OF ACTION OR THEORY OF LIABILITY. IN NO EVENT WILL NVIDIA'S AND ITS AFFILIATES TOTAL CUMULATIVE LIABILITY UNDER OR ARISING OUT OF THESE TERMS EXCEED US\$10.00. THE NATURE OF THE LIABILITY OR THE NUMBER OF CLAIMS OR SUITS SHALL NOT ENLARGE OR EXTEND THIS LIMIT.

These exclusions and limitations of liability shall apply regardless if NVIDIA or its affiliates have been advised of the possibility of such damages, and regardless of whether a remedy fails its essential purpose. These exclusions and limitations of liability form an essential basis of the bargain between the parties, and, absent any of these exclusions or limitations of liability, the provisions of these terms, including, without limitation, the economic terms, would be substantially different.

9. Governing Law; Dispute Resolution

8.1 Governing Law. These terms and all disputes that may arise from it or out of use of the NVIDIA LaunchPad and User Content

in interstate commerce shall be governed by the Federal Arbitration Act, in addition to the internal substantive laws of the State of Delaware and the United States, without regard to or application of its conflict of laws rules or principles. The United Nations Convention on Contracts for the International Sale of Goods is expressly disclaimed. You agree to these terms in the English language unless NVIDIA provided you these terms in another language.

8.2 Arbitration. For any claim against or dispute with NVIDIA relating to these terms or your use of the NVIDIA LaunchPad and any User Content, please give NVIDIA a chance to resolve it and contact NVIDIA by U.S. Mail at NVIDIA Corporation, ATTN: Legal, 2788 San Tomas Expressway, Santa Clara, California, 95051. For any disputes that are not resolved informally, you and NVIDIA each agree to resolve any such dispute (excluding any NVIDIA claims for injunctive or other equitable relief) by binding arbitration before an arbitrator from Judicial Mediation and Arbitration Services ("JAMS") located in Santa Clara County, California under the Optional Expedited Arbitration Procedures then in effect for JAMS, except as provided herein. The arbitration will be conducted in Santa Clara County, California (or the nearest JAMS Office to Santa Clara County), unless you request an in-person hearing in your hometown or you and NVIDIA agree otherwise. Nothing in these terms shall prevent a party from seeking injunctive or other equitable relief from the courts in any jurisdiction to prevent the actual or threatened violation of that party's data security, intellectual property rights, or other proprietary rights. If for any reason this agreement to arbitrate is found not to apply to a dispute and as a result a dispute proceeds in court rather than in arbitration, the dispute shall be exclusively brought in state or federal court located in Santa Clara County, California.

8.3 Class Action & Jury Trial Waiver. ALL CLAIMS MUST BE BROUGHT IN THE PARTIES' INDIVIDUAL CAPACITY, AND NOT AS A PLAINTIFF OR CLASS MEMBER IN ANY PURPORTED CLASS OR REPRESENTATIVE PROCEEDING. THIS WAIVER APPLIES TO CLASS ARBITRATION UNLESS SUCH ARBITRATION IS NECESSARY TO EFFECTUATE THE ENFORCEMENT OF THE COURT CLASS ACTION WAIVER OR IN THE EVENT THAT CLASS ARBITRATION IS EXPRESSLY AGREED TO BY NVIDIA. YOU AGREE THAT, BY ENTERING INTO THESE TERMS, YOU AND NVIDIA ARE EACH WAIVING THE RIGHT TO A TRIAL BY JURY OR TO PARTICIPATE IN A CLASS ACTION.

8.4 Right to Opt-Out. YOU MAY OPT-OUT OF THE FOREGOING ARBITRATION AND CLASS ACTION/JURY TRIAL WAIVER PROVISION OF THESE TERMS BY NOTIFYING NVIDIA IN WRITING WITHIN 30 DAYS OF COMMENCEMENT OF USE OF THE NVIDIA LAUNCHPAD. SUCH WRITTEN NOTIFICATION SHALL BE SENT TO ATTN: LEGAL, 2788 SAN TOMAS EXPRESSWAY, SANTA CLARA, CALIFORNIA, 95051 AND SHALL INCLUDE (1) YOUR NAME, (2) YOUR ADDRESS, (3) THE REFERENCE TO NVIDIA LAUNCHPAD AS THE SERVICE THE NOTICE RELATES TO, AND (4) A CLEAR STATEMENT INDICATING THAT YOU DO NOT WISH TO RESOLVE DISPUTES THROUGH ARBITRATION AND DEMONSTRATING COMPLIANCE WITH THE 30-DAY TIME LIMIT TO OPT-OUT.

10. Miscellaneous

10.1 You agree that you will not assign these terms or your rights and obligations by any means or operation of law without NVIDIA's permission. These terms do not create any third-party beneficiary rights.

10.2 If it turns out that any provision of these terms is not unenforceable, such provision will be construed as limited to the extent necessary to be consistent with and fully enforceable under the law and the remaining provisions will remain in full force and effect. Unless otherwise specified, remedies are cumulative.

10.3 If NVIDIA needs to contact you about the NVIDIA LaunchPad or User Content, you consent to receive the notices by email or through the NVIDIA LaunchPad and agree that electronic notice will satisfy any legal communication requirements. Please direct your legal notices or other correspondence to NVIDIA Corporation, 2788 San Tomas Expressway, Santa Clara, California 95051, United States of America, Attention: Legal Department.

10.4 You acknowledge that any software, technology or technical data provided by NVIDIA under these terms are subject to U.S. export controls and the service is subject to U.S. economic sanctions regulations. By using the NVIDIA LaunchPad, you confirm that you do not normally reside in any country currently embargoed by the U.S. and that you are not otherwise prohibited from receiving any software, technology or technical data.

10.5 These terms are the entire agreement between you and NVIDIA concerning the NVIDIA LaunchPad and User Content. If you do not comply with these terms, and NVIDIA doesn't take action right away, this doesn't mean that NVIDIA is giving up any rights that NVIDIA may have (such as taking action in the future).

10.6 NVIDIA may make changes to these terms from time to time. NVIDIA will publish the new terms at the NVIDIA LaunchPad. The updated terms will be effective when published. Please review the NVIDIA LaunchPad terms of use on a regular basis. You understand and agree that your express acceptance of the updated terms of use or your use of the NVIDIA LaunchPad after the date of publication shall constitute your agreement to the updated the NVIDIA LaunchPad terms of use. If you do not agree with the updated terms, you must terminate your use of the NVIDIA LaunchPad.
