

- 1. This document provides information on the status of submission and review of NC8s and BR5s from Annex I Parties as at 6 May 2024.
- 2. COP 25 requested Annex I Parties to submit their NC8s and BR5s to the secretariat no later than 31 December 2022.¹ In addition, COP 17 adopted the "UNFCCC biennial reporting guidelines for developed country Parties" and decided that developed country Parties shall use them when preparing their BRs.² COP 18 adopted the CTF for those guidelines³ and COP 21 revised it and decided that developed country Parties shall use the revised format when preparing and submitting their BRs in accordance with decision 2/CP.17.⁴
- 3. At the time of preparation of this document, the secretariat had received NC8s from 43 Annex I Parties; Ukraine had not yet submitted its NC8. A total of 28 Annex I Parties submitted their NC8s before the due date of submission. All NC8s received have been posted on the UNFCCC website.⁵
- 4. In addition, the secretariat had received BR5s from 43 Annex I Parties, of which 42 had also submitted their BR5 CTF tables. Ukraine had not yet submitted its BR5 or BR5 CTF tables and Hungary had not yet submitted its BR5 CTF tables. A total of 28 Annex I Parties submitted their BR5s and 27 Annex I Parties submitted their BR5 CTF tables before the due date of submission. All BR5s and BR5 CTF tables received have been posted on the UNFCCC website.⁶
- 5. COP 20 decided that the "Guidelines for the technical review of information reported under the Convention related to greenhouse gas inventories, biennial reports and national communications by Parties included in Annex I to the Convention" shall be used for the review of BRs, starting with R2s in 2016.⁷ The guidelines state that, in the years in which NCs and BRs are submitted together, both will be subject to an in-country review and that Annex I Parties with total emissions of less than 50 million tonnes of carbon dioxide equivalent (excluding land use, land-use change and forestry) according to their most recent greenhouse gas inventory submission, with the exception of Parties included in Annex II to the Convention, may choose for their NCs to undergo a centralized review.⁸
- 6. As at 6 May 2024, the secretariat had coordinated the reviews of 43 Parties' NC8s and BR5s. Seven Annex I Parties with total emissions of less than 50 million tonnes of carbon dioxide equivalent (excluding land use, land-use change and forestry) according to their 2022 greenhouse gas inventory submission (Bulgaria, Estonia, Latvia, Lithuania, Monaco, Slovakia and Slovenia) opted for a centralized review, which took place in Bonn from 27 to 31 March 2023.
- 7. In-country reviews were conducted for 5 Parties (European Union, Finland, Netherlands (Kingdom of the), Spain and United States of America) in February–March 2023, 7 Parties (Austria, Cyprus, France, Greece, Ireland, Malta and United Kingdom of Great Britain and Northern Ireland) in April–May 2023, 8 Parties (Belgium, Czechia, Denmark, Germany, Italy, New Zealand, Romania and Sweden) in September–November 2023 and 14 Parties (Australia, Canada, Croatia, Hungary, Iceland, Japan, Kazakhstan, Liechtenstein, Luxembourg, Norway, Poland, Portugal, Switzerland and Türkiye) in January–April 2024. The reviews of the NC8s and BR5s of Belarus and the Russian Federation, owing to the geopolitical situation in their region, were conducted in Bonn from 16 to 20 October 2023 following the in-country review format to the extent possible.
- 8. Following the reviews referred to in paragraph 6 above, 18 Parties resubmitted their NC8s, BR5s and BR5 CTF tables, 10 Parties resubmitted their NC8s and BR5s and 8 Parties resubmitted their BR5 CTF tables.

- 9. Of the reviewed Parties, 13 underwent multilateral assessment, to which the report on the technical review of the Party's BR5 serves as input, at SBI 59. For the rest of the reviewed Parties, 15 will be multilaterally assessed at SBI 60 and 15 at SBI 61.
- 10. The table below presents the dates of submission and review of the NC8s, BR5s and BR5 CTF tables, and of publication of the reports on the technical review thereof, as at the time of preparation of this document.
